COMMERCIAL WATER TAP INFORMATION

In order to begin the commercial water service application and plan review, the following items must be submitted to the Westwood North Water Supply Corporation (WNWSC) Office:

- 1. A deposit of \$2,500 to be applied towards Tap Fees, Engineer Review, and related Fees.
- 2. The WNWSC's Application Form complete with Owner, Agent, and Design Professional contact information (name, firm, phone, fax, email, and address).
- 3. Three (3) copies (1 PDF form optional) of a Professional Engineer's or Architect's project description and water demand information for the water service sizing. For office and retail, this should be done per the International Plumbing Code guidelines using fixture counts and distances. For other uses, this can be left to the design professional's preference, but modifications may be requested. It should include an average daily usage in gallons.
- 4. Three (3) sets of plans (1 pdf form optional) including a site plan, utility plan, floor plan with occupancies and square footages, fire sprinkler plan (if applicable), irrigation plan (if applicable), and relevant details. Either a Professional Engineer or an Architect shall prepare plans.
- 5. Provide specific detail of fixture counts with flows. The fixture count should include number and fixture type with flow requirements of each (inclusive of hot and cold). There is some guidance for this in the International Plumbing Code 2006, Appendix E. Be sure to also include the peak flow rate expected.

Please note that this is the initial required information and that additional information will be required as requested to complete the process.
